

LEGAL NOTICE

The regular monthly meeting of the Arkansas Game and Fish Commission will be held beginning at 9:00 a.m. Thursday, March 19, 2015, at the Little Rock Office Complex, 2 Natural Resources Drive, Little Rock, AR 72205. At that time, regulations and business pertaining to the operation of the Game and Fish Commission and other fiscal and administrative matters will be considered and acted upon, and all interested persons are invited to attend. Additionally, Committee meetings attended by Commissioners and agency staff members will be held throughout the day on Wednesday, March 18, 2015, beginning at 10:00 a.m. at the same location, and all interested persons are invited to attend.

Items on the agenda for the March 19, 2015, 9:00 a.m. meeting will include adoption of proposed regulations previously considered at the February 19, 2015, Commission Meeting, plus various Hunting and Fishing Regulations and regulations pertaining to the Enforcement Division of the Arkansas Game and Fish Commission including, but not limited to:

Regulations for Compliance with Land Use Policies – Proposal for revisions to the Commission's Policies on Land Use Around Arkansas Game and Fish Commission Lakes and amendment of existing regulations to require compliance with such policies around AGFC-owned or –controlled lakes. Also, proposal for amendment of existing regulation to disallow certain activities around AGFC-owned or –controlled lakes, and establish permit and specification requirements for certain structures (including platforms, floating duck blinds, piers, boat slides, boathouses, or irrigation systems) and other activities (including shoreline stabilization; lake dredging; herbicide and pesticide use; shoreline deepening; and lawn irrigation). Also:

- Revision of AGFC Code 19.13 - Permit and Specification Requirements for Structures, now to read: Compliance with Land Use Policies Around Commissioner-Owned or -Controlled Lakes; Permit and Specification Requirements for Certain Structures and Activities; and
- Revision of Addendum Code K1.01 - Policies on Land Use Around Arkansas Game and Fish Commission Lakes.

Contracts to Sell Acreage in Prairie and Desha Counties - Approval of contracts to sell:

- 1.74 acres, more or less, in the Freddie Black Choctaw Island Wildlife Management Area, Desha County to the Arkansas Highway and Transportation Department for I-69 interstate highway development; and
- 1.45 acres, more or less, in the Mike Freeze Wattensaw Wildlife Management Area, Prairie County to the Arkansas Highway and Transportation Department for I-40 interstate highway development.

All persons wishing to be heard on these subjects should submit comments in writing to this office before the start of the April 16, 2015, meeting (preferably by 4:30 p.m. on the day before). Any request to make an oral presentation at the meeting should be submitted in writing to this office on or before March 9, 2015. Copies of any proposed rules or regulations may be
