11.04 -- Special Youth Waterfowl Hunt Restrictions

Approved Regulation

It is unlawful for a person, other than a youth, to hunt ducks, in-season geese, mergansers, and coots during the special youth waterfowl hunt (Addendum <u>B1.13</u>). Shooting hours and bag limits are the same as the regular waterfowl season.

EXCEPTION: Addendum B1.15.

PENALTY: Class 1
