B1.08 Duck, Coot, and Merganser Season and Limits

- 1st segment: the Saturday before Thanksgiving through the first Monday after Thanksgiving
- 2nd segment: the second Wednesday Friday in December through December 233rd segment: December 26 through January 31

EXCEPTION: Ducks, coots, and mergansers may be taken during the Special Youth Waterfowl Hunt (Code 11.04).

LIMITS:

Coot: Daily limit 15, possession limit 45.

Ducks: Daily limit 6. No more than four mallards (no more than 2 of which may be females), 1 pintail, 1 mottled duck, 1 scaup, 3 wood ducks, 2 redheads, 2 black ducks, and 2 canvasbacks. Possession limit no more than 3 daily limits.

Mergansers: Daily limit 5 (no more than 2 of which may be hooded mergansers). Possession limit no more than 3 daily limits

LEGAL NOTICE

The Arkansas Game and Fish Commission is anticipating holding the regular monthly Committee meetings beginning at 9:00 a.m., Wednesday, August 19, 2020, and the monthly Commission meeting at 9:00 a.m., Thursday, August 20, 2020, at the Little Rock Office Complex, 2 Natural Resources Drive, Little Rock, AR 72205. In-person attendance at the meetings may be limited to only Commission members, the Director, representatives of the media, and other individuals necessary to the proceedings as determined by the Commission Chairman and Director. If that is the case, we anticipate that the Committee meetings on August 19 and the Commission meeting on August 20 will be live-streamed for viewing by members of the press and the public and a link for easy access will be available on the agency website. Items on the agenda for the August 20, 2020, meeting will include discussion of proposed regulations that previously were considered at the July 16, 2020 Commission Meeting, plus consideration of various Hunting and Fishing Regulations, including, but not limited to:

• 2020-22 Migratory Bird Regulations - Amend hunting season dates and limits for: Mourning, White-winged, and Eurasian Collared Dove; Teal; Duck, Coot, and Merganser; White-fronted Goose; Snow, Blue, and Ross's Goose; and Canada Goose.

All persons wishing to be heard on these subjects should submit comments in writing to this office before the start of the August 20, 2020, meeting (preferably by 4:30 p.m. on the day before). Any request to make an oral presentation at the meeting should be submitted in writing to this office on or before August 10, 2020.
