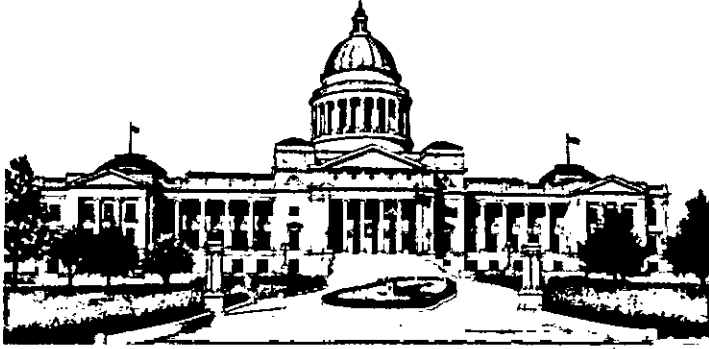

All laws, rules, regulations, or orders in conflict with the regulations in this Code Book are hereby repealed by the Arkansas State Game and Fish Commission.

25.02 Game Fish Possession Limit Restrictions

It is unlawful to possess more than 3 daily limits of game fish.
