The regulations in this Code Book are hereby adopted by the Arkansas State Game and Fish Commission under authority of Amendment 35 to the Constitution of the State of Arkansas. All laws, rules, regulations, or orders in conflict with the regulations in this Code Book are hereby repealed by the Arkansas State Game and Fish Commission.

30.18 Resident Roe Buyer/Exporter And Non-Resident Roe Buyer/Exporter Permit Requirements

NEW TITLE: Cutting Or Mutilation Of Paddlefish And Sturgeon Prohibited

It is unlawful to possess a cut or mutilated paddlefish or sturgeon while on the water unless the eggs have been removed and at least 2 inches of one ovary remains attached to each fish. Mutilation includes tearing or disfiguring of paddlefish in any way near the vent area. A 12-gauge needle may be used to determine the presence of eggs. Eggs must be kept in separate containers, one fish per container.

EXCEPTION: Fish may be blocked out but the carcass must be at least the legal minimum length limit for the water being fished.

PENALTY: Class 4

WHEREAS, the Arkansas Game and Fish Commission and its staff have proposed the attached 2021 commercial fishing regulations; and
WHEREAS, the attached regulations have been communicated through a variety of media avenues to sportsmen and the general public throughout the state for review and comment for at least the past 30 days; and
WHEREAS, after carefully considering the recommendations of Commission staff and the Regulations Committee, as well as comments received from the public, the Commission has determined that the attached regulations promote sound wildlife conservation and management and are consistent with Amendment 35 of the Arkansas Constitution and that these regulations should now be approved for application statewide.

NOW, THEREFORE, BE IT ORDERED this 15th day of October 2020, that the Arkansas Game and Fish Commission hereby approves and adopts the attached regulations, which shall become effective on January 1, 2021, with the exception of the changes to 30.03 Commercial Fishing Reporting Requirements which will take effect on January 1, 2022.

BE IT FURTHER ORDERED that the Commission staff is authorized to proceed with legally certifying and filing the attached regulations with the Secretary of State, State Library, and Bureau of Legislative Research and incorporating them into the Commission Code Book and Addendum.
