The purpose of the Public Hearing will be to determine whether the Director should adopt the Proposed Amended Rule 111, "CRANIOFACIAL ANOMALY RECONSTRUCTIVE SURGERY COVERAGE." The Arkansas Insurance Commissioner is proposing a rule which implements Act 955 of 2021 pertaining to craniofacial anomaly coverage. The Commissioner is refiling a previously filed Rule to obtain public comment on changes made during a previous administrative hearing.

All interested persons are encouraged to make comments, statements, or opinions to the address below or attend the Public Hearing and present, orally or in writing, statements, arguments, or opinions on the proposed Rule. All licensees and other interested persons are responsible for notifying all their personnel, agents, and employees about this Public Hearing. **The record will remain open for public comment until the close of business, March 4, 2022.**

NOTICE OF RULE MAKING AND PUBLIC HEARING

The Arkansas Insurance Department will host a Public Hearing on February 24, at 1:30 PM., in the Second Floor Central High/Old Mill Hearing Room, in the Arkansas Department of Commerce Building, One Commerce Way, Little Rock, Arkansas 72202. The Arkansas Insurance Commissioner is considering adopting proposed amended Rule 111 "Craniofacial Anomaly Reconstructive Surgery Coverage" to consider adoption of a proposed rule which implements Act 955 of 2021, pertaining to insurance coverage for craniofacial anomalies, including but not limited to reviewing or adopting standards related to the following: (1) clarifying that surgical team members may provide authorizations for services; (2) creating time frames consistent with Act 955 of 2021 for reviews and evaluations of craniofacial services for insurance adjudications; (3) permitting fees or charges to insurers for evaluations of proposed services to help resource and pay for ACPA team efforts to review and approve services; (4) providing additional incidental mandates for eye services and out of network charges; (5) providing an authorization form to help simplify approvals for services; and (5) providing definitions not in Act 955 of 2021 to help clarify the craniofacial coverage laws.
