Pursuant to Arkansas Code Annotated § 25-15-201 et seq., notice is hereby given that the Arkansas State Board of Education is considering amending the Rules Identifying and Governing the Fiscal Assessment and Accountability Program, the Rules Governing How to Meet the Needs of Children with Dyslexia, the Special Education and Related Services Section 18.00 Regulations Governing Residential Placement (Second Public Comment), and the Rules Governing Eligibility and Financial Incentives for National Board of Professional Teaching Standards Candidacy and Certification (Second Public Comment—REVISED).
