Pursuant to Arkansas Code Annotated § 25-15-201 et seq., notice is hereby given that the Arkansas State Board of Education and the Division of Elementary and Secondary Education are considering revisions to the following DESE Rules and are releasing them for public comment: Code of Ethics for Arkansas Educators, Educator Licensure, Eye and Vision Screening Report in Arkansas Schools, Creation of School Districts by Detachment, Distance and Digital Learning, Grading and Course Credit, Uniform Grading Scales (Repeal); Concurrent Credit (Repeal); Advanced Placement and International Baccalaureate Diploma Incentive Program and Advanced Placement Courses in the Four Core Areas in Arkansas High Schools with Guidelines for Endorsed Concurrent Enrollment Courses (Repeal).
