Notice of Rulemaking

Pursuant to Arkansas Code Annotated § 25-15-201 et seq., notice is hereby given that the Arkansas State Board of Education and the Division of Elementary and Secondary Education are considering amendments to the following DESE Rules and are releasing them for public comment: (1) School-Based Automated External Defibrillator (AED) Devices and Cardiopulmonary Resuscitation (CPR) Programs in Arkansas Public Schools; (2) Visual and Performing Arts Instruction for Students in Grades One through Eight (1-8)(previously Grades 1-6); (3) Arkansas Educational Support and Accountability Act; (4) Public Charter Schools; (5) Arkansas Military Child Transitions (formerly the Enrollment of Children of Military Families); (6) Eye and Vision Screening in Arkansas Public Schools; and (7) Documents Posted to School District and Education Service Cooperative Websites (Sections 1 and 4 only).

A public hearing concerning these amended rules will be held on February 7, 2022, at 1:30 p.m. at the Arkansas Department of Education, Four Capitol Mall, Little Rock, AR, 72201.
