In compliance with the Administrative Procedure Act of the State of Arkansas (Act 434 of 1967), notice is hereby given that the Alcoholic Beverage Control Board proposes to promulgate rules concerning the alcoholic beverage industry and medical marijuana industry in the state of Arkansas.

The Board will consider rules in the following areas: wine restaurant on premises permit; microbrewery-restaurant distribution permit; combined restaurant beer and wine permit; permits not to be issued to premises within state distances from church or schoolhouse; label and size of containers to be approved by director; advertising and promotional materials exception for racing facilities and nonprofit entities holding a large attendance facility permit; limitation on production; oversight of medical marijuana cultivation facilities, processors and dispensaries; medical marijuana operational rules section 25 – abandonment of license for marijuana cultivation, processor, transporter and dispensary facilities.

The public comment hearing will be held on March 18, 2020, at the hour of 9:00 a.m., in the fifth floor conference room, 1515 West Seventh Street, Little Rock, Arkansas. All interested parties will be afforded an opportunity to present their views at the hearing.
