### **PUBLIC NOTICE**

In compliance with the Administrative Procedure Act of the State of Arkansas (Act 434 of 1967), notice is hereby given that the Alcoholic Beverage Control Board proposes to promulgate rules concerning the alcoholic beverage industry in the state of Arkansas.

The Board will consider rules in the following areas: distiller or liquor manufacturer products; retailer purchase only from permitted wholesaler; manufacturer to sell only to wholesalers; permits for excursion trains; alcoholic beverage deliveries by specific permittees; advertising for microbrewery-private club restaurants; direct shipment of vinous liquor, or mead; definition of mead; and native brandy permits.

The public comment hearing will be held on November 17, 2021, at the hour of 9:00 a.m., in the fifth floor conference room, 1515 West Seventh Street, Little Rock, Arkansas. All interested parties will be afforded an opportunity to present their views at the hearing.
