- (1) <u>Thoroughbred Rule 1151</u>. Amendment to remove term "graded stakes race" from the rule.
- (2) <u>Thoroughbred Rule 1217(D)</u>. Amendment updating change in Model Rule for multiple medication violations.
- (3) <u>Thoroughbred Rule 1257</u>. Amendment to require payment of \$1,500 down payment for court reporter and other costs for appeals before the Commission.
 - (4) Thoroughbred Rule 1260(c)(10) and (d). Repeal of Rules 1260(c)(10) and (d).
- (5) <u>Thoroughbred Rule 1260(e)</u>. Amendment to the Commission's authority to change or alter Steward rulings following hearings.
