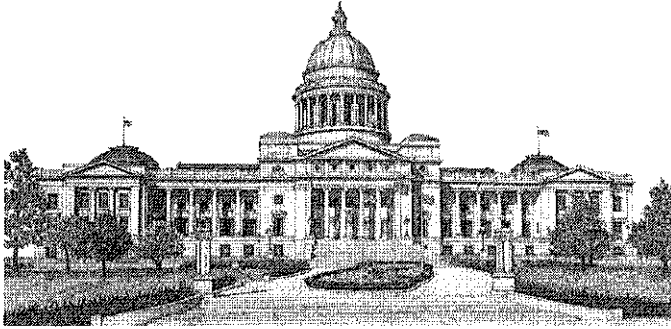

## **Notice of Rulemaking**

The Arkansas State Board of Chiropractic Examiners hereby issue the following proposed amendments to its Rules pursuant to its authority under Ark. Code Ann. §§ 17-81-101 et. seq.

**Pursuant to Act 200 of the 90th General Assembly Fiscal Session (2016) and Acts 139, 315, 426, 645, 820, 990, 1011 of the 92nd General Assembly Regular Session (2019), the Rules of the Arkansas State Board of Chiropractic Examiners are being updated to include new rules for animal chiropractic, licensure for military veterans, pre-licensure background check waiver requests, reciprocity, preceptorship program, and amendments to current rules.**
