Pursuant to Arkansas Code Annotated §25-15-201 et seq., notice is hereby given that the Arkansas State Board of Physical Therapy (Board) is considering proposed revisions to its Rules.

The proposed revisions and modifications to the Rules include, but are not limited to, the following subjects and issues: expedited licensure for uniformed service members, veterans and spouses; pre-licensure criminal background checks; fee waivers for certain qualified applicants; licensure eligibility for certain classes of applicants, and adding a new continuing education auditing process in lieu of annual submissions of proof of CE.
