ARKANSAS STATE REVIEW COMMITTEE BYLAWS

MEMBERSHIP

Composition of the State Review Committee

According to Federal guidelines, the Arkansas State Review Committee shall consist of nine (9) members which include a professionally recognized historian, architect, architectural historian, and archeologist.

Geographic Representation

Membership shall include at least one member from each congressional district.

Terms.

The members are appointed by the Governor to serve one four-year term, with membership submitting their resignation, but may be reappointed by the Governor.

The terms of office will be staggered.

OFFICERS

Officers shall consist of a Chairman, Vice-chairman, and Secretary.

Term

The terms of office shall be one two-year term with the ability to succeed ones self in office, but no more than one consecutive term.

Nomination Process

The offices will be elected by the total committee on the recommendations of a nominating committee made up of three board members appointed by the chairman.
