PET POLICY FOR STATE PARK CABINS AND LODGES

As an accommodation to guests traveling with their dogs, Arkansas State Parks will designate dog friendly eabins lodging. Designated State Park lodges rooms and duplex cabins are not eligible for dog friendly designation (hereinafter referred to as "lodging rental unit.") (Service animals used by disabled guests qualifying under ADA are permitted), but at least one cabin per ten. Twenty-five percent of cabins at applicable state parks and one lodge room per five lodge rooms on the ground floor with an exit in each of the following locations will be established as "dog friendly":

Devil's Den
Lake Catherine
Lake Chicot
Lake Fort Smith
Lake Ouachita

Moro Bay

Mount Magazine
Mount Nebo
Ozark Folk Center
Petit Jean
Queen Wilhelmina
Village Creek

Pet Policy refers only to dogs and no other types of pets are allowed in state park lodging facilities. However, Park staff at each location will keep a list of nearby kennels to direct guests to for their pets.

I. POLICY REQUIREMENTS:

- A. Each guest must sign a dog policy liability agreement and the registration form (see Form 0900 FAC 208 Attachment A, and Attachment C).
- B. Guests renting/reserving a "dog friendly" cabin overnight lodging rental unit will be notified prior to making a reservation that the cabin overnight lodging rental unit is a designated as pet friendly.
- C. Cabin Guests must request a dog-friendly cabin overnight lodging rental unit prior to arrival.

II. POLICY REGULATIONS

- A. The number of dogs per eabin-lodging rental unit is limited to two (2), regardless of size.
- B. A non-refundable fee of \$40 per dog will be collected at check-in and covers the duration of the renter's stay. (See PD 2000 for future-fee rate changes.)
- C. Dogs must be attended all times, at any location in the park, including vehicles. Should it become necessary to leave dogs unattended inside a eabin lodging rental unit, they must be crated. Staff will inform guests of this requirement at the time of registration.
- D. Dog owners are responsible for any damages caused by the pet.
- E. Dog owners are responsible for cleaning up after their pets inside and outside the eabin lodging rental unit.
- F. Dog owners whose dogs create a disturbance that annoys other guests may be asked to leave the park with no refund of remaining <u>lodging</u> rental <u>unit</u> fees.
- G. Dog owners must bring proof of current rabies vaccination records for each dog.
- H. Dogs must be free of ticks, fleas, and mange.
- I. Female dogs must not be in season (in heat).
- J. Dogs may not be tied to trees, fences, or anchored to the ground.
- K. Dogs may not be taken into any park facility that is not designated as pet friendly.
- L. Dogs must be house trained.
- M. Dogs must be on a leash at all times when outside the eabin lodging rental unit.
- N. Extra fees will be assessed when extra cleaning is required or if there is damage to the eabin overnight lodging rental unit, furniture, or fixtures. Park management will assess damage fees based on materials and labor required to make the necessary repairs and /or clean-up.

- O. Park management reserves the right to prohibit any dog on the premises that may pose a risk to guests or staff, or has a history of causing trouble.
- P. Housekeeping staff will complete the Housekeeping Check List for Dog Friendly Rentals (Form 0900 FAC 209, Attachment B). No longer than thirty days after each calendar year, park superintendents will provide a summary report from these check lists to the Manager of Operations with a copy to the Regional Supervisor and Director of Arkansas State Parks. This report is to include an annual occupancy percentage for each dog friendly eabin overnight lodging rental unit.

ARKANSAS STATE PARKS DOG POLICY LIABILITY AGREEMENT

In an effort to accommodate dog owners, Arkansas State Parks now offers designated cabins and lodge rooms for guests who travel with their dogs. The new policy has been established to protect you and to insure all guests enjoy their stay at state park cabins overnight lodging rental units. Rules for guests with dogs staying in pet friendly cabins overnight lodging rental units are as follows:

- There is a \$40.00 fee per dog for the duration of your stay (limit two dogs).
- The fee will be collected at check-in added to reservation.
- Dogs must always be attended any time, anywhere (cabin, vehicle, etc.) The exception will be when a dog is crated inside a cabin an overnight lodging rental unit.
- Dog owners are responsible for cleaning up after their pets in and outside the cabin overnight lodging rental unit area.
- Dog owners whose dogs create a disturbance and annoy other guests may be asked to leave the park with no refund of remaining <u>lodging</u> rental <u>unit</u> fees.
- Dog owners must provide proof of current rabies vaccination records for each dog.
- Dogs must be free of ticks, fleas, and mange.
- Female dogs must not be in season (in heat).
- Dogs may not be tied to trees, fences, or anchored to the ground.
- Dogs may not be taken into other park facilities that are not designated pet friendly.
- Dogs must be house trained.
- Dogs must be on a leash at all times when outside the cabin rental unit.
- Park management reserves the right to prohibit any dog on the premises that may pose a risk to guests or staff or has a history of causing trouble.
- Additional fees may shall be incurred when extra cleaning is required or if any damage to the cabin overnight lodging rental unit or fixtures is discovered. Fee assessments will be based on materials and labor required to make necessary repairs.

As a dog owner, I have read this agreement and will adhere to the terms and conditions herein. I agree to pay any extra charges relating to damage caused by my pet(s). If I have used a credit card to pay the cost of the <u>lodge</u> room(s) <u>and/or cabin(s)</u>, I authorize you to have the additional charges for damage added to my charge bill. I also agree to indemnify the State of Arkansas, Department of Parks and Tourism, and hold the State (AR/ADPT) and its employees harmless for any damage the pets cause to third parties or the property of third parties. I also understand that the State has no responsibility for the safety or care of my pet(s) and release the State from all liability related to their care and safety.
