

## NOTICE OF PROPOSED REGULATION CHANGE, PUBLIC HEARINGS

The Arkansas Pollution Control and Ecology Commission (APC&EC) will hold a public hearing in North Little Rock on September 30, 2016, to receive comments on proposed revisions to APC&EC Regulation 6 (Regulations for State Administration of the National Pollutant Discharge Elimination System (NPDES)). The North Little Rock hearing will begin at 2:00 p.m. in the Commission Room at the Arkansas Department of Environmental Quality (ADEQ) headquarters building, 5301 Northshore Drive, North Little Rock, AR 72118.

APC&EC will hold a second public hearing in Springdale on October 4, 2016, to receive comments on proposed revisions to APC&EC Regulation 6. The Springdale hearing will begin at 6:00 p.m. in the Jones Center for Families, 922 E. Emma Ave., Springdale, AR 72764.

The deadline for submitting written comments on the regulation is 4:30 p.m. (Central Time) October 19, 2016.

In the event of inclement weather or other unforeseen circumstances, a decision may be made to postpone the hearing. If the hearing is postponed and rescheduled, a new legal notice will be published to announce the details of the new hearing date and comment period.

APC&EC authority for revising Regulation 6 can be found in Arkansas Code Annotated §§ 8-6-207(b)(1), 8-4-202(a), and 8-1-203(b)(1)(A).

Proposed revisions to Regulation 6 include adoption of federal revisions to the NPDES program, including sufficiently sensitive test methods, cooling water intake structure requirements, steam electric power generating, and reporting requirements; incorporations of statutory changes passed by the Arkansas General Assembly, which amend the Trust Fund permitting requirements; several minor corrections to make the regulation more illustrative of the legislative and regulatory intent; and a variety of non-substantive and minor stylistic changes in the interest of clarity and consistency.
