DCFS SUMMARY OF CHANGES FOR AUGUST 2011 PROMULGATION

SUMMARY OF DCFS REGULAR PROMULGATION

The purpose of this regular promulgation is to introduce a new policy regarding the Guardianship Assistance Program (GAP) as authorized by A.C.A. § 9-8-201 et seq. This program provides a subsidy to appropriate relatives who are willing to become guardians of children in foster care as outlined in the Arkansas Subsidized Guardianship Act. Due to this new program, policy regarding case reviews has also been updated to include information related to GAP. This promulgation also includes policy regarding mental health services provided to children in foster care that better aligns with best child welfare practice and includes more information on specific types of treatment. Finally, this promulgation includes updated forms to comply with acts passed during the 88th General Assembly, Regular Session 2011.
