NOTICE OF RULE MAKING

The Director of the Division of County Operations of the Department of Human Services announces for a public comment period of thirty (30) calendar days a notice of rulemaking for the following proposed rule under one or more of the following chapters, subchapters, or sections of the Arkansas Code: §§ 20-76-201, and 25-10-129.

Effective April 1, 2021:

The Director of the Division of County Operations (DCO) revises the Supplemental Nutrition Assistance Program (SNAP) Certification Manual sections covering expedited cases. The revisions align current SNAP policy with federal SNAP regulations and ease undue hardships on clients. The changes remove examples and business processes and clarify and standardize language. Also, households granted expedited service will receive the most appropriate certification period if all eligibility requirements are met at the initial interview. Those with verification postponed at the initial interview will be certified for one or two months depending on their application date. Postponed verification must be returned by the end of the certification period or within thirty days of the end of the certification period to be recertified. The rule requires all reasonable efforts be made to verify all eligibility requirements during the expedited review. Also, if verification was previously postponed and not returned, a household must return the verification before receiving expedited services again. However, if it has been twelve months or more since the household last received expedited services the household may receive expedited services.
