

Rule 13. CONSTRUCTION INDUSTRY TRAINING GRANTS

A. ORGANIZATION AND ADMINISTRATION

I. The Arkansas Contractors Licensing Board ("Board") shall administer the Construction Industry Training Grants within the policies set by the Board. All formal communications shall be addressed to or signed by the Administrator of the Board.

II. The final responsibility for setting selection criteria and choosing the grantees shall rest with the Board.

III. The following rules and regulations shall govern the Construction Industry Training Grants given to Apprenticeship Programs, secondary schools offering construction training programs, and coalitions of such programs.

B. GRANT ELIGIBILITY CRITERIA

I. Eligibility Criteria for Apprenticeship Programs

To be eligible to receive a Construction Industry Training Grant, an apprenticeship program must meet the following requirements:

A. The program must be performing actual construction work in Arkansas, the training must take place in Arkansas and the program(s) must be approved by or registered with the State Apprenticeship Office and/or the United States Department of Labor / Bureau of Apprenticeship and Training.

B. Only construction related apprenticeship programs will be approved for grant funding. The list of programs includes but is not limited to the following: Welding, Plumbing, Carpentry, Equipment Operator, Laborer, Sheet Metal Working, Electrical, Ironworker, HVACR Mechanic, Boilermaker, Painting, Glazing, and Insulation Worker.

II. Eligibility Criteria for Secondary Schools

To be eligible to receive a Construction Industry Training Grant, a Secondary School must meet the following requirements:

A. The program must be offered by an Arkansas public secondary school.

B. Only construction related programs will be approved for grant funding. The list of programs includes but is not limited to the following: Welding, Plumbing, Carpentry, Equipment Operator, Laborer, Sheet Metal Working,

Electrical, Ironworker, HVACR Mechanic, Boilermaker, Painting, Glazing, and Insulation Worker

C. APPLICATION PROCESS

I. Application

The application form can be obtained from the Arkansas Contractors Licensing Board staff. The deadline will be established by the Arkansas Contractors Licensing Board.

II. Minimum Standards

Monies for this program are available to qualified construction programs only as determined by the Board.

III. Submission of Applications

All apprenticeship programs, secondary schools offering construction industry training recognized by the Arkansas Department of Career Education and coalitions of such programs may apply for grant funding.

D. AWARD PROCESS

I. The Arkansas Contractors Licensing Board shall have the discretion to determine which programs will receive the grant funding based on the Board's objectives to advance training and education in the construction industry.

II. The Board shall have the discretion to determine which grant applications to fund and to set the specific amount of each grant.

E. GRANT PAYMENT POLICIES

I. Arkansas Construction Industry Training Grants are not automatically renewable. Programs must apply each year and the Board has the discretion to determine which grants will be awarded, if any.

II. The grant funds shall be used only for the advancement of construction related training and education. Grant funds shall only be used as set out in the applicants grant request, as approved by the Board

III. The Arkansas Contractors Licensing Board has the right to review and revisit its determination to distribute grant funds at any time.

IV. All grant recipients must agree to provide a complete accounting of all grant funds expended at the request of the Board.

SUMMARY: In its Budget Appropriation, Act 250 of 2009, the Arkansas Legislature gave the Contractors Licensing Board the authority to issue grants to Construction Industry Training Programs, including construction related apprenticeships and secondary schools in Arkansas. This regulation sets out the procedures and guidelines in distributing the grants to the apprenticeship programs and secondary schools in Arkansas.

Rule 14 CONSTRUCTION TRADES TRAINING GRANTS FOR SECONDARY SCHOOLS

A. ORGANIZATION AND ADMINISTRATION

I. The Arkansas Contractors Licensing Board ("Board") shall administer the Construction Trades Training Grants for Secondary Schools within the policies set by the Board. All formal communications shall be addressed to or signed by the Administrator of the Board.

II. The final responsibility for setting selection criteria and choosing the grantees shall rest with the Board.

III. The following rules and regulations shall govern the Construction Trades Training Grants for secondary schools offering construction training programs.

B. GRANT ELIGIBILITY CRITERIA

To be eligible to receive a Construction Trades Training Grant, a Secondary School must meet the following requirements:

A. The program must be offered by an Arkansas public secondary school.

B. Only construction related programs and coalitions of such programs will be approved for grant funding. The list of programs includes but is not limited to the following: Welding, Plumbing, Carpentry, Equipment Operator, Laborer, Sheet Metal Working, Electrical, Ironworker, HVACR Mechanic, Boilermaker, Painting, Glazing, and Insulation Worker

C. APPLICATION PROCESS

I. Application

The application form can be obtained from the Arkansas Contractors Licensing Board staff. The deadline will be established by the Arkansas Contractors Licensing Board.

II. Minimum Standards

Monies for this program are available to qualified construction programs only, as determined by the Board.

III. Submission of Applications

All programs offering construction industry training in Arkansas public secondary schools and coalitions of such programs may apply for grant funding.

D. AWARD PROCESS

I. The Arkansas Contractors Licensing Board shall have the discretion to determine which programs will receive the grant funding based on the Board's objectives to advance training and education in the construction industry.

II. The Board shall have the discretion to determine which grant applications to fund and to set the specific amount of each grant.

E. GRANT PAYMENT POLICIES

I. Arkansas Construction Trades Training Grants for Secondary Schools are not automatically renewable. Programs must apply each year and the Board has the discretion to determine which grants will be awarded, if any.

II. The grant funds shall be used only for the advancement of construction related training and education. Grant funds shall only be used as set out in the applicants grant request, as approved by the Board

III. The Arkansas Contractors Licensing Board has the right to review and revisit its determination to distribute grant funds at any time.

IV. All grant recipients must agree to provide a complete accounting of all grant funds expended at the request of the Board.

SUMMARY: In its Budget Appropriation, Act 250 of 2009, the Arkansas Legislature gave the Contractors Licensing Board the authority to issue grants to Construction Trades Training Program in Arkansas secondary schools. This regulation sets out the procedures and restrictions in distributing the grants to such construction related programs in secondary schools Arkansas.
