Light Building construction is <u>new</u> construction, <u>alternations or repairs</u> of commercial projects for which the cost of materials and labor <u>is less than</u> does not exceed Five Hundred Thousand Dollars (\$500,000.00) Seven Hundred Fifty Thousand Dollars (\$750,000) in any project and the structure does not exceed two stories in height. Nonstructural alterations and repairs of existing buildings exceeding two stories in height are considered to be Light Building construction if the overall cost of the project does not exceed Five Hundred Thousand Dollars (\$500,000.00) including materials and Labor.
