EMERGENCY RULE  
adopted by the  
ARKANSAS HEALTH SERVICES COMMISSION (COMMISSION)  
on January 17, 1990

"THE HEALTH SERVICES AGENCY (AGENCY) SHALL NOT ACCEPT FOR REVIEW ANY APPLICATION OR APPLICATIONS FOR PERMITS OF APPROVAL WHERE A REQUEST OR REQUESTS FOR THE SAME TYPE OF SERVICE OR FACILITY IN THE SAME SERVICE AREA AS THE SUBJECT APPLICATION IS PENDING BEFORE THE AGENCY OR COMMISSION FOR REVIEW OR APPEAL UNTIL THE TIME HAS EXPIRED FOR PARTIES TO APPEAL TO THE CIRCUIT COURT FOR JUDICIAL REVIEW OF ACTION ON THE PENDING APPLICATION(S)."

This Emergency Rule was adopted to protect public health and safety and to not unduly disrupt the process of ensuring adequate health services and facilities.
