EMERGENCY RULE

on

RESIDENTIAL CARE FACILITIES

The six (6) month moratorium on the acceptance of Permit of Approval applications for Residential Care Facilities (RCF) is hereby extended for an additional six months. During this time period the Commission will form a Committee to recommend standards and criteria. The only applications accepted for review after July 18th, 1990 will be from applicants who have previously contacted the Office of Long Term Care or the Health Services Agency about a specific RCF proposal and can provide written documentation of that contact.

Due to the ongoing Legislative Session, this rule has not been reviewed by the Legislative Council. Consequently, this is as an emergency rule only until such time that it can be reviewed by the Council. Pending favorable advice by the Legislative Council, the rule will be re-submitted as a permanent rule.
