NOTICE OF PUBLIC HEARING RESCHEDULED DATE

Pursuant to Arkansas Code Ann. §§ 23-61-108 and 25-15-201 *et seq.*, and other applicable Arkansas laws or rules, NOTICE is hereby given that the previously scheduled PUBLIC HEARING for October 24, 2007, at 1:00 p.m., has been **rescheduled for November 29, 2007, at 1:00 p.m.** in the First Floor Hearing Room, Arkansas Insurance Department ("Department"), 1200 West Third Street, Little Rock, Arkansas. The purpose of the Public Hearing is to determine whether the Insurance Commissioner should adopt Proposed Rule 87, "TITLE INSURANCE", and Proposed Rule 88, "TITLE INSURANCE LICENSING AND APPOINTMENT FEES", as permanent Rules. The purpose of Rule 87 is to provide guidance to Title Insurance Agents, Title Insurance Agencies, Title Insurers, and the Title industry as regulation of Title Insurance Agents and Agencies is moved from the Arkansas Title Insurance Agents' Licensing Board to the Department in January of 2008. The purpose of Rule 88 is to set out the specific fees established and provided by Rule 87.

All interested persons are encouraged to attend the Public Hearing and may appear and present, orally or in writing, statements, arguments or opinions on the proposed Rules. All licensees and other interested persons are responsible for notifying all their personnel, agents, and employees about this Public Hearing.

Persons wishing to testify should notify the Legal Division as soon as possible, and are requested to submit intended statements in writing in advance.
