NOTICE OF DATE CHANGE FOR RULEMAKING AND PUBLIC HEARING



Notice is hereby given that the public hearing to consider the proposed changes to the Arkansas Gas Pipeline Code in Arkansas Public Service Commission Docket Number 14-029-R, was previously scheduled to occur on August 26, 2014 in the Commission's Hearing Room at the Arkansas Public Service Commission Building in Little Rock, but Order #4 entered by the Commission on August 15, 2014, changed the date of said hearing.
