sas. The purpose of the hearing
is to consider proposed amend-
ments to the Commission's Rules
For Conservation and Energy Effi-
ciency Programs (CAEE Rules) to
change the dates from April 1 to
May 1 as the due date for the an-
nual filing deadlines for the en-
ergy efficiency programs filed by
the utilities. Any interested person or entity
