PURCHASE OF BLUE LIGHT/LENS
SALE & PURCHASE OF OFFICIAL LAW ENFORCEMENT INSIGNIA

ARKANSAS STATE POLICE
RULE 1998-1

SECTION 1: PURPOSE

It shall be unlawful to sell or transfer a blue light or blue lens cap to any person other than a law enforcement officer or a county coroner. It shall be unlawful to buy or sell official law enforcement insignia to any person other than a law enforcement officer.

This rule is hereby promulgated in compliance with Arkansas Code Annotated 25-15-201 et seq. and under the authority of Acts 497 and 1281 of 1997 as codified in Arkansas Code Annotated 5-77-201 et seq.

SECTION 2: DEFINITIONS

As used in this rule the following definitions apply:

(E) "Arkansas State Police" shall mean the Division of Arkansas State Police.
