### NOTICE OF PROPOSED RULE CHANGES

Division of Arkansas State Police Rules for Licensing and Regulation of Private Investigators, Private Security Agencies, Alarm Systems Companies, Polygraph Examiners, and Voice Stress Analysis Examiners

Pursuant to Arkansas Code Ann. §§ 25-15-201 et seq., and other applicable Arkansas laws, NOTICE is hereby given that the Division of Arkansas State Police intends to revise the existing version of the Rules for Licensing and Regulation of Private Investigators, Private Security Agencies, Alarm Systems Companies, Polygraph Examiners, and Voice Stress Analysis Examiners. Specifically, the changes include: replacement of the term "Department" with the term "Division;" omit any reference to "regulation(s);" revision to Rule 2.4 to permit reciprocal and temporary licensing; addition of one (1) disqualifying offense to Rule 2.10(e); addition of Rule 2.16 to establish a process for prelicensure criminal background review; addition of Rule 2.17, which allows for expedited registration for certain military-affiliates; and the addition of an organization authorized to provide alarm systems training in Rule 9.0 and 9.1.

All interested persons are asked to be responsible for notifying their personnel and employees about the Proposed Rule Changes.
