## **NOTICE OF RULE MAKING AND PUBLIC HEARING ARKANSAS ETHICS COMMISSION**

NOTICE is hereby given that the Arkansas Ethics Commission intends to amend its existing Rules on Campaign Contribution Limit, Rules on Campaign Finance & Disclosure, Rules on Conflicts, Rules on Independent Expenditures, Rules on Lobbyist Registration and Reporting, Rules on Political Committees, and Rules of Practice and Procedure. The proposed amendments to the rules are intended to implement and administer the provision of Acts 240, 315, 341, 342, 545, 547, 661, 845, 879, 894, 1039, and 1058 (2019 Regular Session of the 92<sup>nd</sup> General Assembly); Act 1280 (2015 Regular Session of the 90<sup>th</sup> General Assembly); and to further implement and administer applicable provisions of the laws under the Commission's jurisdiction.
