Proposed rules are:

"Electronic Monitoring After 120 Days Served," this rule provides for monitoring offenders using electronic devices when offenders are released pursuant to Arkansas law section 16-93-711. Pursuant to Act 895 of 2015, eligibility criteria for releasing inmates from prison and placement on electronic monitoring are being revised. "Policy and Procedure Development," this rule provides guidance to Arkansas Community Correction staff regarding development and maintenance of agency policy guidance. "Reentry Facilities," this rule describes reentry facilities and programs to include licensing in an effort to ensure a structured, positive, affordable, and safe reentry environment for inmates who are transitioning from prison into a community. "Public Release of Offender Information," this rule is being revised to allow and require release of additional offender information on the agency website as required by recent legislation to be codified in Arkansas law section 12-27-125.
