## NOTICE OF RULE CHANGE Request for Public Comment

The Arkansas Oil and Gas Commission (AOGC), has proposed amendments to Commission General Rule B-26 General Lease Operating Requirements; General Rule H-1 Class II Disposal Class II Commercial Disposal Enhanced Oil Recovery Injection (EOR) and Class V Brine Disposal Well Permit Application Procedures; General Rule H-2 Well Construction, Operating and Reporting Requirements for Class II Disposal and Enhanced Oil Recovery (EOR) Injection Wells. Oral and written comments by industry representatives and the public will be received and made a part of the record during the public comment period.
