### State Plant Board Quarterly Meeting and Public Hearings

The Arkansas State Plant Board will meet at 9:00 a.m., December 5, 2012 at the State Plant Board offices, #1 Natural Resources, Drive, Little Rock, AR.

1. **Public Hearing** to consider changes to the Rice Planting Seed Regulations contained in Plant Board Circular 11, “Regulations on Plant Diseases and Pests”.

The hearing will be to consider establishing the 2013 and subsequent years requirements for having all rice planting seed submitted for testing to detect the presence of the LL601 trait.
