## State Plant Board Quarterly Meeting and Public Hearings

The Arkansas State Plant Board will meet at 9:30 a.m., December 16, 2013 at the State Plant Board offices, #1 Natural Resources Drive, Little Rock, AR.

1. **Public Hearing** to consider changes to the Rules and Regulations for the Arkansas Boll Weevil Eradication Program contained in Plant Board Circular 11, "Regulations on Plant Diseases and Pests".

The hearing will be to consider establishing the Boll Weevil Eradication Regulations for 2014 and subsequent years and establishing the per acre assessment for the NE Delta Zone to be equal to the per acre assessments of the adjacent zones.

2. **Public Hearing** to consider changes to the Arkansas Pest Control Regulations contained in Plant Board Circular 6, "Arkansas Pest Control Law".

The hearing will be to consider changes to the regulations contained in Circular 6 that clarify which employees a pest control business must register as an agent and to clarify the type of work an agent trainee, that has failed the agent registration exam, can perform until such time the trainee re-takes and passes the exam.
