I. Public Hearing

1. <u>Public Hearing</u> to consider adopting changes in the National Institute of Standards and Technology's (NIST) Handbooks 44 and 130.

The hearing will be to consider amending established regulations for commercial weighing and measuring devices, the sale of commodities (articles of commerce) sold in the state and regulations governing fuels and lubricants sold in the state. For the purpose of making Arkansas Weights and Measures and Fuels and Lubricants regulations uniform with the most recent guidelines published in the NIST Handbooks 44 and 130.

2. <u>Public Hearing</u> to consider additions to the regulations on the sale of planting seed in Plant Board Circular 10, "Regulations on the Sale of Planting Seed in Arkansas".

The hearing will be to consider adding instructions on re-labeling the germination test date on expired seed labels. The retailer where the seed is located generally is responsible for re-testing and re-labeling. The method used is often just an oversticker with the new test date. Currently there are no instructions in our regulations on how this should be accomplished to help ensure the seed is being relabeled correctly. The proposed addition is wording recommended by the Association of American Seed Control Officials' (AASCO) in their "Recommended Uniform State Seed Law".
