State Plant Board Quarterly Meeting and Public Hearing

The Arkansas State Plant Board will meet at 10:00 am, December 12, 2017 at the State Plant Board offices, #1 Natural Resources Drive, Little Rock, AR.

1. **Public Hearing.** The hearing will be to consider changes to the Arkansas Pesticide Control Act Regulation, Regulations under Act 410. ACA 2-16-402 (b).

The proposed regulations would allow the Plant Board to request additional information about a pesticide before it is registered for use in the State of Arkansas.
