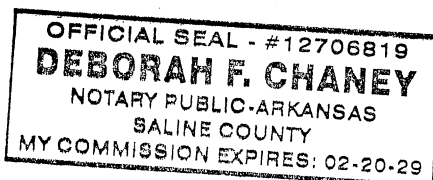

Pursuant to Arkansas General Assembly Act 818 of 2019, the Division of Arkansas Heritage of the Arkansas Department of Parks, Heritage, and Tourism has proposed the addition of "Criterion E (Area)" to the administrative rules regarding listings in the State Register of Historic Places. This proposed addition, once finalized, will permit the listing of geographic areas in the State Register of Historic Places and permit the designation of listed geographic areas as an "Arkansas Heritage Site".
