## **Public Notice (Notice of Rulemaking)**

Pursuant to Arkansas Code Annotated § 25-15-201 et seq. notice is hereby given that the Department of Labor and Licensing, Arkansas Appraiser Licensing and Certification Board is considering changes to its rules. The proposed rule changes include the following subject: Correction of definitions, Clean-up language, Recording of public meetings, Added Registered Apprentice appraiser classification and requirements; Revised the process for the denial of a credential; Clarified when and where an appraiser's signature is required, Removed fee for a replacement credential; Revised the education approval process for consistency, Removed the terminology "moral turpitude", Added a section for military veterans which provides expedited credentialing, Removed the requirement that the Uniform Standards of Professional Appraisal Practice courses be taken in a classroom setting; Revised Reciprocity, Temporary Practice Permits and Transfers to Arkansas, Supervisory Appraiser requirements and responsibilities are revised and worded to correspond with "The Real Property Appraiser Qualification Criteria," and added a section to detail Criminal Background checks and pre-licensure criminal background checks.
