Notice of Rulemaking

The Arkansas Department of Labor and Licensing's Board of Barber Examiners hereby issue the following proposed amendments to its Rules pursuant to its authority under Ark. Code Ann. § 17-20-206.

The Board is updating its existing rules to update the offenses that may receive a waiver in the criminal background process mandated by Ark. Code Ann. § 17-3-101 *et seq.*; to update existing rules regarding licensure for military personnel per Ark. Code Ann. § 17-4-101 *et seq.*; to provide for a fee waiver mandated by Ark. Code Ann. §17-5-104; to provide for licensure of individuals with a "work permit" mandated by Ark. Code Ann. §17-1-109; to update existing Rules #4 Objectional Establishments, #8 Barber College/School Curriculum and #16 Fee's.
