The Arkansas Auctioneer's Licensing Board hereby issue the following proposed amendments to its Rules pursuant to its authority under Ark. Code Ann. § 17-17-207.

The Board is amending its existing rules to provide for the criminal background process mandated by Ark. Code Ann. § 17-3-101 et seq.; to update rules to provide for Automatic Licensure of Active Duty Service Members, Returning Military Veterans, and Spouses per Ark Code Ann. § 17-1-106; to clarify the reciprocity process per Acts 1011/426 of 2019; and to remove the term "Regulation" per Act 315 of 2019.
