Notice of Rulemaking

The Arkansas Department of Labor and Licensing/Arkansas Auctioneer's Licensing Board hereby issue the following proposed amendments to its Rules pursuant to its authority under Ark. Code Ann. § 17-17-207.

The Board is updating its existing rules to update the offenses that may receive a waiver in the criminal background process mandated by Ark. Code Ann. § 17-3-101 et seq.; to update existing rules regarding licensure for military personnel per Ark. Code Ann. § 17-4-101 et seq.; to provide for a fee waiver mandated by Ark. Code Ann. § 17-5-104; to provide for licensure of individuals with a "work permit" mandated by Ark. Code Ann. § 17-1-109; and to remove the phrase "good moral character" per Act 990 of 2019.

This proposed policy is available for review at the Auctioneer's Licensing Board's office, 900 W Capitol, Little Rock, AR 72201. You may also access it on the Board's website at <https://www.aralb.com/>. All public comments must be submitted in writing to the Auctioneers Licensing Board no later than January 7, 2022.
