ADMINISTRATIVE RULES PERTAINING TO THE LICENSING OF HEATING, VENTILATION, AIR CONDITIONING AND REFRIGERATION CONTRACTORS

SECTION XXIII. THE INTERNATIONAL MECHANICAL CODE

- (1) The Board hereby adopts and incorporates herein the International Mechanical Code, 2021 edition of the International Code Council, Inc., commonly referred to as the ICC.
- (2) The International Mechanical Code, 2021 shall be the standard for the conduct of HVACR work.
